#### Important notes:

- 1. In the absence of specific provisions in this decision, SOHAR Freezone rules and regulations shall be applied.
- 2. The fees referred to in this decision shall be reduced by (50%) for small and medium enterprises (holders of Riyada cards).
- **3.** An administrative fine of (5%) of the value of the due fee for services shall be imposed for each (30) days of delay, calculated after (30) days from the due date of the fee, with rounding up the month to a full month and rounding up the Omani Rial to one Omani Rial.
